WHAT IS THE CHRISTMAS COVENANT?

The Christmas Covenant is a set of constitutional amendments and legislative proposals that seeks to decolonize current polity by establishing regional equity in the structures of the church for missional effectiveness while sustaining connectional unity.

GUIDING PRINCIPLES

- ► We are all children of God.
- Ubuntu: an African concept that embodies a way of life based on interdependence, community, and relationships.
- Bayanihan: a Filipino practice of community spirit and cooperation to achieve communal goals.

VALUES

The Christmas Covenant lifts up the following values:

Connectional relationships rooted in mission
Respect for contextual ministry settings

Legislative equity for regional bodies of the church

WHAT WILL IT DO IF PASSED AND RATIFIED?

1. Transforms central conferences into regional conferences.

2. Creates a U.S. Regional Conference as proposed by the Connectional Table.

3. Upon adjournment of the General Conference, the U.S. Regional Committee can convene to do business as allowed under the present Book of Discipline and begin planning for what it will do after constitutional amendments are ratified. Composition: all delegates to the General Conference from the United States of America and two representatives from each regional conference outside the US.

WHAT WILL IT DO IF PASSED AND RATIFIED?

4. Maintains jurisdictional conferences in the U.S. and allows other regional conferences to create jurisdictional conferences within their region. Bishops will be elected by jurisdictional conferences in regions that have jurisdictions. When a region does not have jurisdictions, then bishops are elected at the regional conference.

5. Transforms the existing Standing Committee on Central Conferences into the Standing Committee on Regional Conferences outside the U.S.

6. Creates equity among regional conferences by giving them legislative power to adopt policies and practice ministry and to contextualize mission in their own contexts.

WHAT WILL IT DO IF PASSED AND RATIFIED?

7. Prevents a regional conference from having other regional conferences impose their contextual policies and ministry practices on it.

8. Maintains General Agencies, Judicial Council, Council of Bishops, United Women in Faith, and other GC-created groups.

9. Maintains our doctrinal standards (Articles of Religion and Confession of Faith), the Theological Task and Social Principles passed by GC.

10. Authorizes a study to perfect the new regional conference structure that will be reported to the next General Conference.

11. Maintains the unity of the church for global mission.

OVERVIEW OF CONSTITUTIONAL AMENDMENTS

Purpose: Create regional conferences around the globe, including in the United States.

Goal: Achieve global equity between the regional conferences for effective contextual mission work.

How? Give regional conferences constitutional powers beyond even what central conferences presently have.

PETITION 1: CONSTITUTIONAL AMENDMENTS

Amends The United Methodist Church's Constitution to create regional conferences on a global basis, and revises language throughout the Book of Discipline from "central conference/s" to "regional conference/s."

These amendments strengthen the ability of regional conferences to adapt the Book of Discipline to meet the missional needs of each region.

Current Powers of Central Conferences:

"To make such rules and regulations for the administration of the work within theirboundaries including such changes and adaptations of the General Discipline as the conditions in the respective areas may require, subject to the powers that have been or shall be vested in the General Conference."

Proposed Powers of US Regional Conference (CT proposal):

Par 35: *"The regional conference shall have the following powers and duties:*

1. To make such rules and regulations for the administration of the Church's work within its boundaries, including such changes and adaptations of the General Book of Discipline as the conditions in the regional conference may require, subject to the powers that have been or shall be vested in the General Conference.

2. To appoint a judicial court to determine legal questions arising on the rules, regulations, and such revised, adapted, or new sections of the regional conference Discipline enacted by the regional conference.

3. Such other duties and powers as may be conferred by the General Conference, provided that the regional conference has no authority over duties assigned to the jurisdictional conferences in $\P\P$ 23-27. "

Proposed Powers of Regional Conferences (Christmas Covenant):

"To make changes or additions to the General Discipline in the following areas as the conditions and the mission of the Church in the region may require provided that no change shall be made to a portion or provision of the General Discipline which the General Conference has by a twothirds vote prohibited from being changed:

a. To define and fix the conditions, privileges, and duties of Church membership, which shall in every case be without reference to race, gender, or status.

b. <u>To define and fix the qualifications, powers and duties of elders,</u> <u>deacons, supply preachers, local preachers, exhorters, deaconesses, and</u> <u>home missioners without reference to race, gender, or status</u>....

d. To supplement the hymnal and ritual of the Church and matters relating to the form and mode of worship, subject to the limitations of the first and second Restrictive Rules....

g. To allow the annual conferences to utilize structures unique to their mission, other mandated structures notwithstanding.

h. <u>To make changes in the chargeable offenses and/or their mandatory</u> <u>penalties</u>..."

ON NUMBER AND BOUNDARIES OF REGIONAL CONFERENCES: PAR 16.12

The General Conference shall have full power:

"To change the number and the boundaries of regional conferences upon the consent of a <u>two-thirds</u> of the annual conferences in each regional conference involved."

MAKES POSSIBLE JURISDICTIONAL CONFERENCES FOR ALL REGIONS: PAR 10

"There may be jurisdictional conferences for the work of the Church within the boundaries of a regional conference, with such powers, duties, and privileges as are hereinafter set forth."

ONLY REGIONAL CONFERENCES CAN MAKE CHANGES IN ITS JURISDICTIONS : PAR 31.8

How Regional Conferences can make changes in jurisdictions:

"To establish jurisdictional conferences by dividing all of the area within its boundaries into jurisdictional conferences, and also to abolish such plan of jurisdictional conferences provided that a majority of annual conferences within each jurisdiction consent to the abolishment of the jurisdictional conferences. Changes in the number, names, and boundaries of the jurisdictional conferences maybe effected upon the consent of a majority of the annual conferences of each of the jurisdictional conferences involved."
